# 4-H FAIR GENERAL RULES

1. **4-H Entries:** All entries must be made on official entry cards, available from the extension office, or at the 4-H Fair. Entry cards must be filled out for each exhibit before approaching the judging table.

**Pre-Entries:** Pre-entries are required for some exhibits. Pre-entries made after the designated due date are eligible for ribbons, but cannot compete for Grand & Reserve Champion.

**County Fair Entries - Junior Division:** At the conclusion of the 4-H judging 4-H entries may be entered in the County Fair - Junior Division where a class exists. Entering of the items in the junior division will be the responsibility of the 4-H member.

2. **4-H Requirements:** Exhibitors must be bona fide Sumner County 4-H Members. Members can exhibit only from those projects in which they are enrolled. All exhibits must be the result of the current year's project work and produced by the exhibitor.

- 3. **Removal of Exhibits:** All exhibits will be released at the scheduled time on the last day of the fair unless division rules state otherwise.
- 4. All 4-H members must exhibit at the 4-H Fair or Spring Show (where classes are provided) to be eligible to attend the Awards Banquet. In case of an emergency, exhibiting at the fair may be excused.
- 5. **Awards:** (a.) Group system of awards will be followed in all divisions. Purple, Blue, Red or White ribbons will be awarded. No purple ribbons are awarded in livestock. Special Awards are listed within each department. Superintendents may rule exhibits unacceptable judges will determine if grand and reserve champion awards will be given.
- (b.) Ribbons, but not premiums, should be awarded in events where the member's ability rather than his project is being judged. Such events include demonstrations, fashion revue, fitting and showing, judging, performance classes for horses, etc. This policy is in line with an agreement between the State 4-H Office and the Kansas High School Activities Association, and has a direct bearing on a student's amateur standing.
- 6. **Premiums:** Premiums will be awarded after the 4-H Fair, if money is available. Errors should be reported to your club leader or 4-H Agent immediately for correction.
  - 7. Kansas State Fair entries may be made according to limits and classes listed in the Kansas State Fair 4-H Premium Book, www.kansasstatefair.com.
  - 8. The superintendents will supervise the receipt of all articles or animals in their departments and assign them to their proper places. Superintendents may create new classes when necessary.

## Superintendents decisions are final and override any printed matter.

- 9. Livestock General Rules:
- a. Number of animals entered per species will be as follows:

Beef: 2 Market and 2 Breeding
Swine: 2 Market and 2 Breeding
Goats: 2 Market and 2 Breeding

b. 4-H Members must provide suitable care, feed, and equipment for livestock exhibits.

Premium money will be forfeited if animal is not satisfactorily cared for.

- c. Exhibitors with two entries in one class may have another 4-H member show one entry, with approval of the division superintendent.
- d. 4-Hers are encouraged to have purebred or registered breeding livestock. Grade animals may be exhibited.
- e. All market animals' tag numbers must be listed on the official weigh-in sheet to be eligible to show.
- f. Animals will be inspected at entry by Superintendent and/or vet. Animals deemed unfit will be denied entry to fair and fairgrounds. .
- g. Exhibitor must own and tag the following animals by the dates listed to be eligible to show.
  - \* Market Beef by May 1, of current year
  - \* Bucket Calf, Market Swine, Market Lambs, and Meat Goats by June 15, of current year.
- h. Exhibitor must own the following animals by the dates listed to be eligible to show.
  - \* Breeding Beef, Swine, Sheep, & Meat Goats by June 15, of current year.
  - \* Dairy Goats and Dairy Cows, by May 1, of current year.
- i. Exhibitors are responsible to provide their own bedding.
- j. Only animals entered in the fair will be allowed to stall or pen at the fair.
- k. Set-up and Clean-up Policy If an exhibitor cannot make set-up night, arrangements must be made by superintendent or County Agent to work prior to fair. Livestock exhibitors must check out with superintendent or County Agent on final cleanup. If these conditions are not met, \$50.00 may be held from fair premiums or livestock sale proceeds.
- 1. When cleaning pens or working with animals, put waste in truck. DO NOT leave piles in or around the livestock barn. Do not put waste in trash barrels.
- m. GROOMING: Each Exhibitor must groom his or her own animal and may use only the assistance of an immediate family member (mother, father, legal guardian, brother or sister), another 4-H or FFA member who is an exhibitor at the fair, FFA Advisor or 4-H Project Leader. This rule will be strictly enforced and any exhibitor violating it will have their animal in question eliminated from competition. Anyone wishing to report unauthorized people grooming animals must sign a complaint at the Fair Office, that includes names of the owner, animal tag number, time and date of the observation. A committee appointed by the Fair Board will take action. Sheep/Goat Divisions: All market lambs, commercial ewes and goats must be "slick shorn:, above the knee and hock joints including the head, before arrival on the Fair grounds. A maximum of 0.2 (two tenths) inch of wool is permitted on market lambs and commercial ewes. A maximum of 0.4 (four tenths) inch of hair is permitted on market goats. Hair on the tail switch may be left on goats. There will be no shearing of market lambs, commercial ewes or goats allowed on any part of the grounds after arrival. Anyone found in violation will have his or her electric clippers temporarily confiscated and that animal will be disqualified. Touch-up clipping with scissors or hand shears will be allowed. No artificial coloring/use of adhesives is allowed on market lambs and commercial ewes.
- n. Livestock released at the discretion of the Superintendent.

# **DIVISION A – CLOTHING**

- 1. All garments made by 4-H member will be judged on August 1, 2015. More information will be sent on time and place to those enrolled in project. Garments must be exhibited in 4-H Fair in Caldwell to qualify for ribbons and premiums. No 4-H judging will be done during the fair.
- 2. Exhibitors may enter all items made in the Clothing & Textiles project for the age level of the exhibitor.
- 3. Pre-cut kits are acceptable. Care labels are not required, however, the judge may ask the care of the garment.
- 4. An outfit is two or more pieces that can be worn together. Do not exhibit purchased items.
- 5. All garments should be on hangers, cleaned and pressed.
- 6. Recycled Clothing Project-An item made of at least 50% recycled material (recycled means reusing an existing item in a new way). Could be remaking/redesigning a garment, re-purposing a clothing item for a new use, etc. Must include sewing of some kind. A 3"x5" index card must accompany entry describing the recycled materials and how they were used in the item.
- \*Class 1 An article, garment or outfit constructed by 7-8 year old exhibitor
- Class 2 An article, garment or outfit contructed by 9-11 year old exhibitor
- Class 3 An article, garment or outfit contructed by 12-14 year old exhibitor
- Class 4 An article, garment or outfit contructed by 15-18 year old exhibitor
- Class 5 Educational exhibit
- Class 6 Recycled clothing project

# **Section 2: Buymanship**

# \*Class 25 Buymanship Window Display

Open to all 4-hers enrolled in Clothing Buymanship. Use garments purchased for the project during the current 4-H year. Exhibitor is responsible for props and display materials. Display is limited to 36"H x 32" W. Include in the display an information sheet no larger than 8 ½ x 11" that explains the purpose, occasion, cost, how the item fits in your wardrobe plan, including how to extend wear through multiple seasons, a picture of you in the outfit and any other pertinent information about your clothing display entry. The display of accessories (one shoe, jewelry, scarf, bags, etc.) is optional and should be securely fastened in the display. Pictures of the accessories may be displayed on the backdrop to add to the display board. (May sit on the table, but must be attached to display.) Display setup by the 4-H member will be on Thursday evening or Friday morning of the Sumner County Fair. Judging will begin at 10:00 am on Friday.

#### **DIVISION B – FOODS**

- 1. Recipes are required for all food product exhibits. No alcohol should be included as an ingredient in food entries. Entries with alcohol in the recipe will be disqualified and not be **judged.**
- 2. 4-H'er may make four different entries in the age level for the current 4-H year. Remove baked products from baking pans and place on heavy paper plates or on foil covered cardboard that fits the size of the product. Place in a clear plastic bag -large cakes will fit in turkey bags. Plastic wrap and light paper plates are not acceptable.
- 3. All unfrosted cakes shall be exhibited in upright position with top crust showing (angel food, sponge, and chiffon cakes).
- 4. Non-Perishable foods meet food safety guidelines. Food safety purposes, any food with custard and cream cheese type fillings and frostings, favored oils, "canned" bread or cakes in a jar, or food requiring refrigeration will not be judged. Refer to K-State Research and Extension publication, 4-H 712, Food Safety Recommendations for Acceptable Fair Exhibits, for information to help you make informed, safe food exhibit decisions. - 5. Cakes may be made from your favorite recipe or commercial mix.
- 6. Food Gift Package Food items will be tasted by judge. These foods items should not be entered separately as other food exhibits. Maximum size of 18" including container. *No Alcoholic Beverages allowed.*
- 7. Educational Exhibits cannot exceed standard 3' x 4' trifold display board.
- 8. Modified food product must be modified from original recipe to nutritionally enhance the food product. Attach one-8½ inch page (front and back) that include Original Recipe, Modified Recipe, and Narrative to describe modifications were made and lessons learned such as nutritive value, or changes in appearance, doneness, aroma, flavor, tenderness and/or texture. Example: a standard blueberry muffin recipe that is modified to make it gluten free. - 9. Exhibitors receiving purple ribbons must meet State Fair guidelines to enter in the State Fair.

# FOOD PRESERVATION

Open to all 4-H members enrolled in Foods project

1. Recommended method of processing must be used. Follow guidelines in K-State Research and Extension food preservations publications or "USDA;s Complete Guide to Home Canning"; or "So Easy to Preserve, 6<sup>th</sup> Edition, Cooperative Extension Service The University of Georgia"; or "Ball Blue Book of Preserving"(2012 or later). Open kettle canning and oven canning will be disqualified. Pickles and sweet spreads must be processed using the water bath process for the altitude of residence. Low acid products must be pressure processed properly for the altitude of residence. Refer to following K-State research and Extension publications for more information:

Homemade recipes or other untested recipes will be disqualified for safety reasons.

- 2. Alcohol is not allowed as an ingredient in food preservation entries. Entries with alcohol in the recipe will be disqualified and not be judged.
- 3. Each member may enter up to two exhibits in this division, but only one entry per class.
- 4. Each exhibit must have the complete recipe and instructions attached with the entry card, or it will be lowered one ribbon placing. Recipe must include exhibitor name, recipe source, date of publication and altitude of residence.
- 5. Exhibits must be sealed in clean, clear standard canning jars, with matching brand (ex: use Ball lids on Ball jars, or Kerr lids on Kerr jars, etc.)two piece lids. Do not use colored jars. Do not add fancy padded lids, fabric over wraps or cozies as they interfere with the judging process. No fancy packs unless recipe states to do so (ex: (pickled asparagus) Jars must be sealed when entered. Jelly must be in half pint or pint jar. All other products must be in pint or quart jars. Note: There are 12-ounce and 24 ounce canning jars available and may be used. Use pint jar canning process recommendations for 12 ounce jars. Use quart jar process recommendations for 24 ounce jars.
- 6. Each jar exhibited must be labeled. The label must not cover brand name of jar. The label must give: Class No. Product, Altitude of Residence, Canning Method (water bath, weighted gauge or dial gauge pressure method), process Time, Pressure (psi), date processed including month and year, Name, and County/District. Templates to make adhesive labels can be found at: http://www.kansas4h.org/p.aspx?tabid=46
- 7. Classes 130 136 will require on jar for each class.
- 8. Hole punch the entry card and use a rubber band to attach the entry card and recipe around the top of the jar.
- Class 130- Sweet Spreads (Fruit and /or Vegetables), Syrups; One jar
- Class 131- Fruits, Juices, Fruit mixtures (Salsa, Pie Filling, etc.) One jar
- Class 132- Low Acid Vegetables (green beans, corn, etc or vegetable mixtures.); one jar
- Class 133- Pickles (Fruit or Vegetable) Fermented Foods and Relishes and Chutney; One jar
- Class 134 Tomato/Tomato Products Tomato Juice and Tomato Salsas; One jar
- Class 135 Meats; One jar
- Class 136 Dried Foods: One kind of dried food product exhibited in a small canning jar. If dried food product is not in a canning jar, it will be lowered on ribbon rating. Suggested amount: 1/3-1/2 cup, or three or four pieces per exhibit. All meat jerky must be cooked to an internal temperature of 160 degrees F before or after drying. Dried products must include the recipe and preparation steps. Jerky not heated to an internal temperature of 160 degrees F will be disqualified and not be judged. # **DIVISION C - FIBER ARTS**

- 1. Exhibitor may make four entries per class.
- 2. When articles which are worn normally as a pair are exhibited, both articles must be shown together
  - fastened together securely with yarn.
- 3. The exhibitor may also attach a 3" x 5" index card with the entry form to give the judge any information which the exhibitor thinks would be helpful for the judge to know.
- 4. If a pattern is used, attach it to the article by thread or yarn
- 5. Non-textile projects such as wood reed, straw, grass, etc. should be entered in the Visual Arts Department.

# **4-H BANNER RULES**

- 1. All banners must be the work of the current year.
- 2. Each banner should illustrate a phase of 4-H work which is practiced by boys & girls in 4-H.
- 3. Banners are a two dimensional display, depicting one idea.
  - a. Banners must be hung on a wooden dowel rod strong enough to support the banner. On each end of the dowel rod there must be a chain 6" long. On the other end of the chain attach an "S" hook so the banner can be hung on wire in the fair building.
  - b. Dimensions are to be no less than 12 and no more than 16 square feet, with no side less than 3 feet.
  - c. Banners should be made out of flame-resistant materials.
  - d. Three dimensional objects can be attached to the banner.
  - e. A label is to be attached to the lower left-hand corner of the banner giving the name of the 4-H club, county, and year. Waterproof inks prevent smearing and is recommended for th label.
  - f. Copyright Laws: Exhibitors should avoid using copyrighted materials. To search if an item is copyrighted go to the US Copyright Office at <a href="https://www.copyright.gov/">www.copyright.gov/</a> Click on Search Copyright Records.

#### SPECIAL AWARDS:

The Sumner County Farm Bureau will award \$50.00 for Top Display with Safety Theme.

The 4-H Council will sponsor the following awards to Displays promoting 4-H:

1st Place - \$30, 2nd Place - \$20, 3rd Place - \$10

### **DIVISION H – PHOTOGRAPHY**

- 1. Photography exhibited must be the result of the current year's work.
- 2. Each exhibitor will be allowed four entries from project(s) in which enrolled.
- 3. Photographs are required to be exhibited on studio mount or white poster board.
- 4. To be eligible for the State Fair all photos must be no larger than 8" x 10" and no smaller than 7" x 9", after trimming. Photos not going to the State Fair must be at least 4" x 6". They are to be mounted across the narrow (11") dimension of an 11" x 12 ½" sheet of white studio mount, with the top edge of the print 1" below the top of the cardboard and with the sides of the print equal distance from the two sides of the mounts. A permanent mount should be made using photographic adhesive mounting. Remove white border from enlargement before mounting.
- 5. No lettering will be permitted on the mount or the pictures. No underlays or borders are to be used. The white trim should be removed from the enlargement.
- 6. Name, address, and county name should be written on the back of each mount.
- 7. Studio mounts are available at cost from the Extension Office.
- 8. Photographs taken with a digital camera and having no more adjustments than exposure, color intensity or correction, one click filter effects, red eye removal, cropping, dodging and burning should be entered in the standard color or black and white classes.
- 10. Digital images that have had objects added or removed, multiple filter effects applied or black & white and color combined.
- 11. Photos with live subjects on railroad right of way or taken from railroad right of way property will not be displayed and will be disqualified and not judged.
- **Class 140** 1 3 year photographer, color photos.
- Class 141 4 7 year photographer, color photos.
- Class 142 8 or more years photographer, color photos.
- Class 143 Black & White photos.
- Class 144 Digital Composite Image Photo must be created from trwo or more originals taken by the exhibitor. Exhibitor must include a second 11x 12-1/2 matte board mounted with standard size print or prints (if more than one photo was used) of the original photo(s) and 3x5 card(s) explaining what manipulation was done.
- Video Entries must be full motion not a series of still images with pan or zoom motion added by a software program. All content must be the result of the current year's project work. All content must be original and created by the exhibitor(s) unless signed copyright, use and/or performance releases are provided. Entries may be created by an individual or by a team. Talent, computer editing, titles, graphics, animation and music are allowed and recommended. Entries must be one of the following production types: Instructional, Informational, Documentary, Persuasive/PSA, Story or Entertainment. Length must be no longer than three minutes with the exception of Persuasive/PSA which must either be 30 seconds or 60 seconds. #### **DIVISION K – ENERGY MANAGEMENT**

- 1. Open to all 4-H members enrolled in the electric project. One entry per class. Limited to one article to show at State Fair.
- 2 On label state: Basic, Intermediate or Advanced after the class number. These levels will be judged separately. Members and leaders should follow leader's guide in selecting articles in each phase. Exhibits should be operable (batteries furnished by exhibitor). If exhibit is advanced or operations questioned an instruction sheet should be included.

#### **Electrical Electronics**

Class 205 AC Electric Projects. Electric projects with a 110 or 120 V alternating current (AC) power source. Some project examples are household wiring demonstrations, small appliances extension cords, trouble lights, indoor or outdoor wiring boards, or shop lights. Projects may be a restoration of original construction. The project must be operational and meet minimum safety standards. AC projects must be 110/120 V, no 240 V exhibits are allowed, and must be constructed such that the judges have access to examine the quality of workmanship.

Class 206 DC Electric Projects. Electric projects with a battery or direct current power source. This class includes electric kits or original projects. This class also includes demonstration DC powered projects. Examples include: wiring two or three way switches, difference between series/parallel lighting circuits or wiring doorbells switches. All DC electric projects must work with batteries supplied by 4-H'er. Projects must be constructed such that the judges have access to examine the quality of wiring workmanship.

Class 207 Electronics Projects. Electronic projects with a battery or direct current power source. This class includes electronic kits or original projects. Examples include radios, telephones, toy robots, light meters, security systems, etc. May be constructed using printed circuit board, wire wrap, or breadboard techniques. Include instruction/assembly manual if from a kit. Include plans if an original project. Projects must be constructed such that the judges have access to examine the quality of wiring workmanship.

**Class 208** Educational Displays and exhibits. This class includes any educational displays, exhibits or science fair projects which DO NOT have a power source, i.e. exhibits, posters or displays of wire types, conduit types, electrical safety, tool or motor parts identification or electrical terminology. A maximum tri-fold size of 3' x 4'.

# **SMALL ENGINES**

All exhibits should involve engines smaller than 20 horsepower for classes 209-213 Displays are limited to 4' wide and 4' deep – both upright and floor displays.

- **209 Display** Exhibit a display, selecting one of the following options: 1) a display identifying different engine or lawn and garden equipment parts or a display showing the function of the various engine or lawn and garden equipment parts; OR 2) a display identifying and explaining the functions(s) of different special tools needed for small engine work; OR 3) a display illustrating and providing the results of any one of experiments that are included in the project books. No complete engines, lawn tractors, tillers, chainsaws are permitted for display. Maximum tri-fold size is 3'x 4'.
- **210 Maintenance** Exhibit a display that illustrates either 1) Routine maintenance procedures OR 2) Diagnosing and trouble shooting specific problems in an engine. No complete engines, lawn tractors, tillers, chainsaws, etc. are permitted for display using a maximum tri-fold size of 3' X 4'.
- **211 Operation** Exhibit an operable small engine (no more than 20 HP) overhauled or rebuilt by the member. Include maintenance schedule for the engine and a brief description of steps taken by the member overhauling or rebuilding the engine. Maximum tri-fold size is 3' X 4'. Engine should contain no fuel in tank or carburetor.

Alternative ENERGY (A form of energy derived from a natural source, such as the sun, geothermal, wind, tides or waves. All exhibits in this division are limited in size to standard, tri-fold, display boards (36" X 48") and items may not extend beyond 12" from the back board. All displays must be self standing.

- **212 Educational Display** Create an exhibit that addresses a focused topic related to power generated from a renewable energy source. The purpose of the exhibit is to inform and create awareness.
- **213 Experiment** Display an experiment addressing a problem or question related to power generated from a renewable energy source. Include hypothesis, background research, variables, a control, data, findings, conclusions and recommendations for future study.

### **ROCKETRY**

- 1. Rockets are to be properly assembled, uniformly and smoothly finished, and painted.
- 2. Each rocket exhibited must be able to stand freely by itself or be supported by a wooden base, not to exceed 4 1/4" thick x 8" square for small and medium-sized rockets; wooden or metal support rods must not extend past the tip of the nose cone. SUPPORT RODS MUST REMAIN IN THE UPRIGHT POSITION. DO NOT ANGLE. Rockets may not be exhibited on launch pads.
- 3. Angles of the fins must fall within a plus or minus 2 degree variation and rounded or streamlined to reduce drag.
- 4. Live engines and igniters are NOT permitted with the exhibit.
- 5. Beginner kits with prefabricated fin assemblies, pre-finished rockets not requiring painting, and plastic snap together fins not requiring alignment are not acceptable, **participation ribbon only**.

# **DIVISION M - ENTOMOLOGY & GEOLOGY ENTOMOLOGY**

# **GENERAL GUIDELINES**

- All entries should be submitted in an 18 X 24 X 3.5 inch wooden display box with a clear plastic top. Boxes can be handmade or purchased as long as they are of the correct size and do not have a glass top.
- Identification should follow the taxonomy included in www.bugguide.net.
- Each exhibitor is required to identify each box by placing an identification label bearing exhibitor's name, county or district and the class. One label goes in the upper left corner of the box (inside) and the other on the lower right corner of the box (outside). Arrange specimens in the box so it can be displayed lengthwise.
- The number of orders, specimens (and families where required) must be included on the exhibitor's box identification label. Only adult specimens can be used in collection boxes.
- Arrangement of specimens: The preferred method is to arrange the insects in groups or rows parallel to the short sides of the box. Arrangements that run lengthwise of the box are frequently downgraded in judging. Specimens are to be arranged by Order in the box, then family where required.
- For each collection class, two labels will be centered on the pin beneath each specimen. First (closest to the specimen) is the common name label and the second label should include date/locality. Full county name, state abbreviation and collector name on the second label are encouraged for 2015 and will be required in 2016. The specimens should be collected by the exhibitor and should focus on Kansas and neighboring states. Other specimens from the continental United States may be included as long as properly labeled.
- Emphasis in judging will be placed on the overall variety of insects represented in the collection, accuracy of identification, skill and technique acquired in mounting of specimens, and overall arrangement and appearance of the collection.
- Specimens of soft bodied insects such as aphids, lice, termites, etc. should be exhibited in alcohol filled vials; however, the use of alcohol filled vials should be limited to only those specimens that lose their shape when pinned, since the vials pose a significant hazard to the rest of the collection if they become loose in transit

# Class 181 - BEGINNING I ENTOMOLOGY COLLECTION

Display in one standard box a minimum of 50 and a maximum of 125 species representing at least 7 orders. Follow the general guilelines listed for Collections. Members can exhibit in this class a maximum of 3 years, or until they receive a purple ribbon at the Kansas State Fair, whichever comes first.

Class 182 – BEGINNING II ENTOMOLOGY COLLECTION - Display in one standard box a minimum of 75 and a maximum of 150 species representing at least nine (9) orders. Follow the general guidelines listed for collections. Members can exhibit in this class a maximum of 3 years, or until they receive a purple ribbon at the Kansas State Fair, whichever comes first.

Class 183 – INTERMEDIATE ENTOMOLOGY COLLECTION – Display a minmum of 100 and a maximum of 300 species representing at least 10 orders. Two standard boxes can be used. Follow the general guidelines listed for Collections. In addition, family identification is required for all insects in any two of the following six orders: orders of Orthoptera, Hemiptera, Odonata, Coleoptera, Diptera, and/or Hymenoptera. Members can exhibit in this class a maximum of 3 years.

Class 184 – ADVANCED ENTOMOLOGY COLLECTION - - Display a minimum of 150 and a maximum of 450 specimens representing at least 12 different orders. Three standard boxes can be used. Follow the general guidelines listed for Collections. Family identification is required for all insects belonging to the six basic orders as outlined under the Intermediate phase. Family identification of insects in the remaining orders is optional, but desirable as long as accuracy is maintained. All butterflies appearing in the collection should be labeled with the correct common name. Members may continue to exhibit in this class at the Kansas State Fair for an unrestricted number of years as long as they remain eligible for 4-H membership.

# **EDUCATIONAL DISPLAY CLASSES**

- All entries should be submitted in an 18 X 24 X 3.5 inch wooden display box with clear plastic top. Boxes can be handmade or purchased as long as they are of the correct size and do not have a glass top.
- Information on numbers and kinds of insects is not needed for educational exhibits.
- Displays may consist of specialized groups of insects or their close relatives, or relate to any aspect of their behavior, biology or
- Displays should be presented in a clear, concise, and interesting manner.
- Displays should include only work performed during the current year.. 5.
- Title of the exhibit should be indicated inside the box.
- The purpose of the project is to learn more about the importance, life cycles, biology, ecology, diversity, etc. of insects and related arthropods. Subject matter can be as varied as the animals themselves.
- Creativity is encouraged!

## ENTOMOLOGY COLLECTION NOTEBOOKS

- **Class 190 Introductory Entomology Collection Notebooks -** Display in 3 ring notebook a collection of photos. Minimum of 10 and a maximum of 30 insect species representing at least six different orders. Species pages should be grouped according to order. (Notebooks should contain 15 to 60 photos).
- Class 191 Beginning Entomology Collection Notebook Display in 3 ring notebook a collection of photos. Minimum of 30 and maximum of 60 insect species representing at least seven different orders. Species pages should be grouped according to order (Notebooks should contain 50 to 120 photos).
- Class 192 Intermediate Entomology Collection Notebook Display in 3 ring notebook a collection of photos. Minimum of 60 and a maximum of 100 insect species representing at least nine orders. Species pages should be grouped according to order. Pictures in any two of the following six orders should be identified to family: Orthoptera, Hemiptera, Homoptera, Coleoptera, Diptera, and/or Hymenoptera. (Notebooks should contain 100 to 200 photos).
- Class 193 Advanced Entomology Collection Notebook Display in 3 ring notebook a collection of photos. Minimum of 100 insect species representing at least twelve orders. Species pages should be grouped according to order. In addition, family identification is required for all insects in the following six orders: Orthoptera, Hemiptera, Homoptera, Coleoptera, Diptera, and Hymenoptera. Family identification in the remaining orders is optional, but desirable as long as accuracy is maintained. (Notebooks should contain at least 150 photos).

# **GEOLOGY**

- 1. The standard size exhibit box should be 18" x 24" x 3 ½". All specimens are to be arranged with top being the 18" dimension of the exhibit box. If the box has a sliding cover, it must be removable from the top.
- 2. Each exhibitor is required to identify each display box by placing an identification label with *Name*, *County*, *Class Number & Number of Specimens* on the inside of box, upper left-hand corner, and a second label for back of the box on the outside.
- 3. Geology specimens should be labeled number of specimens, date collected, specimen name or description, and locality (county) where found, by proper groups rocks, minerals, fossils.
- 4. All specimens must be collected from locations in Kansas
- 5. All specimens must be collected from locations in Kansas.
- Class 365 Display at least 15 different rocks, minerals or fossils collected during the current 4-H year. Limited to one exhibit box (18" x 24" x 3 ½") with plexi-glass cover. Fossils must be identified to the Phylum level.
- **Class 366** Display at least 30 different rocks, minerals or fossils; at least 5 of each. Exhibit must include at least 15 specimens of current year's work. Limited to one exhibit box. Fossils identified to the Phylum level.
- Class 367 Display at least 45 rocks, minerals or fossils; at least 5 of each. Exhibit limited to two boxes (18" x 24" x 3 ½") with plexiglass cover. Exhibit must include at least 15 specimens of current year's work. Rocks must be identified by their proper name and type. Fossils identified to the Phylum level.
- Class 368 Display at least 60 rocks, minerals, or fossils, at least 5 of each. Exhibit limited to two boxes 18" x 24" x 3 ½" with plexiglass cover. Exhibit must include approximately 15 specimens of current year's work. Rocks must be identified by their proper name and type. Fossils must be identified to the Phylum, Class, and Genus levels if possible.

# **DIVISION N – VISUAL ARTS & CRAFTS**

- 1. Each exhibitor may make four entries per class in Arts & Crafts.
- 2. Paintings & drawings should be framed/matted prepared for hanging. Other items should be prepared for appropriate display.
- 3. State Fair Participation The number of exhibits that can be displayed in the State Fair Visual Arts & Crafts Division is determined by the State 4-H Office. The Grand and Reserve Champions will represent Sumner County 4-H at the Kansas State Fair.
- Class 65 Original work created by the 4-H member
- Class 66 Non-Original items are made using molds, patterns, kits, copying another's ideas, etc
- Class 67 Ceramics

#### **Livestock General Rules:**

a. Number of animals entered per species will be as follows:

Beef: 2 Market and 2 Breeding Sheep: 2 Market and 2 Breeding Swine: 2 Market and 2 Breeding Goats: 2 Market and 2 Breeding

b. 4-H Members must provide suitable care, feed, and equipment for livestock exhibits.

Premium money will be forfeited if animal is not satisfactorily cared for.

- c. Exhibitors with two entries in one class may have another 4-H member show one entry, with approval of the division superintendent.
- d. 4-Hers are encouraged to have purebred or registered breeding livestock.

Grade animals may be exhibited.

- e. All market animals' tag numbers must be listed on the official weigh-in sheet to be eligible to show.
- f. Animals will be inspected at entry by Superintendent and/or vet. Animals deemed unfit will be denied entry to fair and fairgrounds.
- g. Exhibitor must own and tag the following animals by the dates listed to be eligible to show.
  - \* Market Beef by May 1, of current year
  - \* Bucket Calf, Market Swine, Market Lambs, and Meat Goats by June 15, of current year.
- h. Exhibitor must own the following animals by the dates listed to be eligible to show.
  - \* Breeding Beef, Swine, Sheep, & Meat Goats by June 15, of current year.
  - \* Dairy Goats and Dairy Cows, by May 1, of current year.
- i. Exhibitors are responsible to provide their own bedding.
- j. Only animals entered in the fair will be allowed to stall or pen at the fair.
- k. Set-up and Clean-up Policy If an exhibitor cannot make set-up night, arrangements must be made by superintendent or County Agent to work prior to fair. Livestock exhibitors mustcheck out with superintendent or County Agent on final cleanup. If these conditions are not met, \$50.00 may be held from fair premiums or livestock sale proceeds.
- 1. When cleaning pens or working with animals, put waste in truck. DO NOT leave piles in or around the livestock barn. Do not put waste in trash barrels.
- m. GROOMING: Each Exhibitor must groom his or her own animal and may use only the assistance of an immediate family member (mother, father, legal guardian, brother or sister), another 4-H or FFA member who is an exhibitor at the fair, FFA Advisor or 4-H Project Leader. This rule will be strictly enforced and any exhibitor violating it will have their animal in question eliminated from competition. Anyone wishing to report unauthorized people grooming animals must sign a complaint at the Fair Office, that includes names of the owner, animal tag number, time and date of the observation. A committee appointed by the Fair Board will take action. Sheep/Goat Divisions: All market lambs, commercial ewes and goats must be "slick shorn:, above the knee and hock joints including the head, before arrival on the Fair grounds. A maximum of 0.2 (two tenths) inch of wool is permitted on market lambs and commercial ewes. A maximum of 0.4 (four tenths) inch of hair is permitted on market goats. Hair on the tail switch may be left on goats. There will be no shearing of market lambs, commercial ewes or goats allowed on any part of the grounds after arrival. Anyone found in violation will have his or her electric clippers temporarily confiscated and that animal will be disqualified. Touch-up clipping with scissors or hand shears will be allowed. No artificial coloring/use of adhesives is allowed on market lambs and commercial ewes.
- n. Livestock released at the discretion of the Superintendent.

# **DIVISION O – SHOWMANSHIP**

#### **Meat Goats**

- 1. Exhibitor must own and tag all animals by June 15, current year, to be eligible to show.
- 2. Minimum weight for 4-H Fair is 50 lbs (lighter weight animals may be shown). A limit of two (2) goats may be entered per exhibitor.
- 3. Market meat goat classes are open to wether or doe kids of any meat or cross meat goats with milk teeth or showing no breaking or eruption of either of two permanent front teeth.
- 4. All market goats will be shown by weight. Goats will be divided equally into classes as determined by the Goat Division Superintendent.
- 5. Shearing: All goats must be "slick shorn" with an equal amount of hair above the knee and hock before arrival on the grounds. A maximum of 0.4 (four tenths) inch of hair is permitted. Hair on the tail switch is permitted. Shearing is not allowed on any part of the grounds after arrival. Anyone found in violation will have his or her electric clippers temporarily confiscated and that animal will be disqualified. Touch-up clipping with scissors or hand shears will be allowed. No blocking tables are permitted on the grounds in the sheep/goat division. Grooming: Artificial coloring, paint, adhesive, or powder will not be permitted for use on wethers during the entire show.
- 6. Horns do not need to be tipped.
- 7. Halters and show collars will be allowed in show ring; exhibitors will not lift front legs off ground during judging.
- 9. Meat goats cannot show in the Dairy Goat or Breeding Meat Goat Class.

- 6. All market lambs and commercial ewes must be "slick shorn", above the knee and hock joints, including the head, before arrival on the grounds. A maximum of 0.2 (two tenths) inch of wool is permitted. There will be no shearing of market lambs or commercial ewes allowed on any part of the grounds after arrival.

  Anyone found in violation will have his or her electric clippers temporarily confiscated and that animal will be disqualified. Touch-up clippings with scissors or hand shears will be allowed. No artificial coloring or use of adhesives is allowed on market lambs. No blocking tables are permitted on the grounds in the sheep/goat division.
- 7. Grand Champion and Reserve Grand Champion Lambs will be selected.

**Sample Script:** Randy Hein enjoyed 4-H camp last June in this sporty tan shorts and K-State purple short sleeve shirt outfit. Randy really enjoys the clothing project and has learned that you can get some really good buys when the sales are in full swing. He practiced sewing on a button this year and learned to read the care labels on clothes before doing the laundry. Randy is a third year member of the Happy Go Lucky 4-H club.

Script ideas: for other outfits 4-Hers are modeling--

- \*Scripts can be written with the name of their 4-H club at the beginning to add variety.
- \*For a second outfit tell the audience about the 4-H members 3 favorite things to do in 4-H.
- \*For a third outfit tell the audience about 3 achievements or accomplishments in 4-H. (like this is the first year they made a yeast bread or they helped a younger 4-H member build their rocket).
- \*For a fourth outfit tell the audience about 3 achievements or accomplishments in school.
